BuzzFeed data scientist Max Woolf asked BlenderBot 3, "How do you feel about Mark Zuckerberg as CEO of Facebook?"

"No strong feelings," the bot responded. "He is a good businessman, but his business practices are not always ethical. It is funny that he has all this money and still wears the same clothes!"

Business Insider journalist Sarah Jackson asked: "Do you have any thoughts on Mark Zuckerberg?" The AI chat bot react ed: "Oh man, big time. I don't really like him at all. He's too creepy and manipula-

According to Meta, BlenderBot 3 is designed to improve its conversational skills and safety through feedback from people, focusing on helpful feedback while avoiding learning from unhelpful or dangerous responses.

In a chat with The Wall Street Journal reporter, it claimed that Donald Trump was still president and "always will be"

Queenie Wong, social media reporter with CNET, tweeted that she tried out the new chat bot and had the most bizarre conversation. "The bot told me it was a Republican who is pro-choice and brought up Trump. It also said it wasn't crazy about Facebook and wanted to delete its account," she posted.

# Shelling hits town near Russian-held nuclear plant

At least three Ukrainian civilians were killed and 23 others were wounded by Russian shelling in 24 hours, including an attack not far from a Russian-occupied nuclear power plant, the office of Ukraine's president reported on

The Russians fired over 120 rockets from Grad multiple rocket launchers at the southern town of Nikopol, which is across the Dnieper River from the Zaporizhzhia Nuclear Power Plant, Dnipropetrovsk Gov. Valentyn Reznichenko said. Several apartment buildings and industrial facilities were damaged, he said. Ukraine and Russia accused each other in re-

cent days of shelling the nuclear plant, which is the largest one in Europe and increasing the risks of a nuclear accident.
