The election commission has issued detailed instructions with special focus on social distancing and access to sanitization measures for voters and polling officials. The last hour of voting will be for COVID-19 patients and people suspected to be suffering from the disease, additional chief electoral officer Arun Tomar said.

However, family members, relatives and friends of Sirajuddin who reached jail in sizable numbers after receiving information of his suspicious death said, "Sirajuddin can never take such a step."

They also staged a protest outside the jail. City Qazi Khaliqurrehman visited the jail to take stock of the situation. Jail superintendent told him that the deceased was suffering from depression. "Last night, Sirajuddin had told barrack inmates that his father had locked their house and shifted elsewhere and it would cause problems to his wife and children, Sonkar told the qazi. After post-mortem the body was handed over to the family. Meanwhile, jail superintendent informed DG, Jail, DJ, District Magistrate and SP about the incident. She also suspended four employees, including chief guard Goverdhan Singh and guards Arjun Raghuwanshi, Narayan Bagri and Narayan Singh Tomar for dereliction of duty. A three-tier inquiry has also been initiated. JMFC Meenu Pachori visited the jail for judicial probe. Secondly, Bhairavgarh police along with FSL team also collected evidence. Thirdly, jail superintendent herself started departmental probe.



According to a Morning Consult poll released Monday and taken on October 22-31, Biden has a lead in Florida and Pennsylvania, the two states considered to be must-wins for Trump to secure another term. Texas, a deeply Republican state that hasn't voted for a Democratic president since 1976, is tied with the likely voters split 48.1 per cent for which candidate they are casting their ballot. According to the rolling poll, the only swing state where Trump is leading is Ohio where he holds 49.2% compared to Biden's 46.6%. Trump hinted at a rally that he might fire Dr. Anthony S. Fauci after Election Day, further heightening the tension between his administration and the nation's top infectious disease expert, even as the number of new corona cases in the US touches new highs. That had the supporters up on their feet, chanting, "Fire Fauci! Fire Fauci!" Trump listened in silence for a few moments before remarking: "Don't tell anybody, but let me wait until a little bit after the election. I appreciate the advice."


